## RULES OF THE COMPETITION

#### Eligibility criteria

All practicing advocates with a standing of at least one year and not more than ten years, shall be eligible to participate in the competition. However, it shall be mandatory for all participants to either be a member of the Punjab and Haryana High Court Bar Association or the District Bar Association, Chandigarh District Courts. A maximum of 30 participants shall be allowed to take part in the competition, on a first come first serve basis.

### Format of the competition

The competition shall be conducted in the following manner-

- All proceedings throughout the competition shall be conducted in English, and all
  participants shall be required to speak in English.
- The competition shall be conducted on an online platform, the details of which shall be
  provided to the participants once the registration is final. It shall be made public for people
  in general to log in to the platform and watch the competition as audience.
- Each round shall have an experienced person working in the field of law as a moderator, who would conduct the session smoothly. Participants shall speak only when asked to do so by the moderator, who would have the authority to mute/unmute all participants. Extension of time, if any, shall also be subject to the discretion of the moderator.
- Each round would be watched carefully by a judge, who would then, at the end of the session, give his feedback and declare the winner of the round. All judges shall be renowned legal luminaries with great experience and impeccable legal acumen.
- Rounds shall be divided into six preliminary rounds, followed by one final round.









- A list of topics for all rounds is being released along with the rules, however, each round shall have a distinct topic, and the participants of a particular round shall be provided with their topic out of the aforementioned list, only two days prior to the round.
- In each round, participants shall get a specified time for their opening speech, in which they
  shall state whether they are for or against a motion, followed by supporting arguments. The
  opening speeches shall be followed by an open debate where all participants would be
  required to speak.
- Six preliminary rounds shall be held with five participants each, where each participant shall get four minutes for the opening speech, followed by fifteen minutes for the open debate under the strict supervision of the Moderator. During the entire session, particularly during the open debate, no participant shall be allowed to speak out of turn and the participants shall speak only when the moderator asks them to. Any unhealthy, uncalled for behaviour by any participant will result into disqualification. The decision of the Moderator and the organising committee shall be final.
- All six winners from the preliminary rounds shall participate in the final round, the topic for which would be given to them one day prior to the round. In the final round, each participant would get five minutes for the opening speech, followed by twenty minutes for the open debate. During the entire session, particularly during the open debate, no participant shall be allowed to speak out of turn and the participants shall speak only when the moderator asks them to. Any unhealthy, uncalled for behaviour by any participant will result into disqualification. The decision of the Moderator and the organising committee shall be final.









## **Disqualification**

Any participant who conducts himself in an unprofessional manner during the rounds, or speaks in a derogatory manner, or does anything that is unbecoming of an advocate, shall be disqualified from the competition. The decision of the organising committee regarding disqualification shall be final and the committee shall also reserve the right to disqualify any participant for any other reason, other than those specified above, if in its reasonable judgment, calls for disqualification.


## REGISTRATION
