Dr Halder has published three books, two authored books and an edited book and many articles in international peer-reviewed journals including the British Journal of Criminology, Journal of Law and Religion, Annals in Criminology, Victims and Offenders and Temida. She served as resource person for many government and non-government organizations. She has been on the Panel Advocate to Child Welfare Committee, Juvenile Justice Board and Juvenile Home at Tirunelveli, Tamil Nadu.
