# GUIDELINES FOR SUBMISSION

*Only the selected abstracts will be permitted for presentation.*

**ABSTRACT:** The abstract should not exceed **300 words** and must be accompanied by a cover page stating the following: -

- Sub-theme of the paper
- Title of the Paper
- Name and Designation of the author (s)
- E-mail address
- Postal address and Contact Number

**FULL RESEARCH PAPER:** The following guidelines should be followed:

- The word limit of the paper shall be **3,000-4,000 words** (exclusive of footnotes).
- The main text of the full paper should be in Times New Roman with font size 12 and line spacing of 1.5.
- The footnotes should be in Times New Roman, font size 10 with spacing of 1.0 (Endnotes are not permitted).
- One inch margins should be maintained on all four sides of the pages.
- Citation Style: Bluebook, 20th edition.
- **Co-authorship is permitted to a maximum of two authors and at least one author must attend the Conference to present the paper.**
- No proxy presentations will be allowed.
- All submissions must be the author's original and unpublished work. Any amount of Plagiarism will attract immediate disqualification.

Full paper with the subject as "**Submission of Full Paper**" must be submitted through E-mail at [slcunationalconference.ncr@christuniversity.in](mailto:slcunationalconference.ncr@christuniversity.in) and the plagiarism report should be **less than 10 %**.

All the papers will be reviewed by a committee of experts with respect to their quality, originality, and relevance. All authors/coauthors will have to register and a co-authorship up to two persons is allowed. All rights of publication of papers presented in the conference shall rest with the conference organizers.
