Quiz Competition: Rules and Regulations

1. Eligibility

- a. The competition is open to all students pursuing law, management, commerce, or any other equivalent program from a recognized University governed by the UGC.
- b. There is no bar on the number of teams per University for participation in the competition, subject to the overall cap on the total number of teams for the competition.
- c. Each team shall comprise of two members. No other person shall be allowed to accompany the team during the competition.
- d. Each team shall be allotted a Team Code designated to them by the Organizing Committee which shall be used for their identification purposes.





Rules and Regulations

2. Registration

- a. Each team must register themselves by filling up the registration form provided below.
- b. The registration shall be considered complete only after payment of registration fees of Rs. 400 per team.
- c. There shall be a cap of <u>20 teams in total</u> for participation in the competition. Registration shall be accepted on a first-come-first-serve basis.
- d. Registration fees is NON-REFUNDABLE, once paid. In case of non-participation in the competition, the Organizing Committee shall not refund the registration fees.

Rules and Regulations

3. Dress Code

All participants shall adhere to the dress code of the competition and shall be in formal wear for the entire duration of the competition.

4. Accommodation and Travel:

All participants are required to make suitable arrangements for their accommodation (if needed) and travel. The Organizing Committee shall not be able to make arrangements for the participants in this regard.

5. Language:

The entire competition shall be in English language only. No other language shall be used for the purpose of communication during the competition.

6. Queries and Clarifications:

The Organizing Committee shall issue clarifications and respond to queries from registered participants from time to time. In case of any dispute or discrepancy, the decision of the Organizing Committee shall be final.
