Disclosure of identity shall lead to immediate disqualification.
4. The Dress Code shall be advocates attire (black and white formals for gentleman and white western outfits or Indian formals for ladies, no gowns and coat bands) to participate.
5. Bonafide students pursuing Five- or Three-Years LL. B Degree Course are only eligible. The students must be deputed by their respective colleges.
6. Participants participating in multiple events shall strictly adhere to the timings specified for each event. The organizers will not be responsible in case of clash of event timings.
7. Participants/ students must carry their respective college ID cards. Entry without the ID cards shall not be permitted.
8. Participants/ students shall not resort to or indulge in any unethical, unprofessional or immoral conduct. If found guilty, the organizers shall reserve the right to take appropriate action.
9. Participants shall bear their own travel and accommodation expenses.
10. The sole right of interpretation of rules and regulations and decision to disqualify in case of failure to follow rules and regulations on part of participating Team's will remain with the Organizers of this event.
11. Any grievance Will be settled by the Grievance Committee and the decision of the committee shall be final and binding.

## MOOT COURT

### MOOT PROPOSITION:

Kavibaba was born in Amatpura, a small town in Saval Pradesh in Bharatvarsh, in a poor peasant family. He is a highly intellectual person. He has been wheelchair-bound since the age of five due to post-polio paralysis. He started working as an Assistant Professor in Karam Anand College affiliated to the University of Bharatvarsh in 2003. He has led a respectable life as a professor.

In 2013, in a violent Maoist attack by the Communist Party of Bharatvarsh (CPB Group) of Saval Pradesh, several people were killed, many injured and public property worth lakhs was destroyed in the Kamroli area of Swarashtra. This attack created fear of threat to the internal security in several neighboring states of Saval Pradesh.

The Communist Party of Bharatvarsh (CPB Group) was a banned Maoist political and militant organisation in Bharatvarsh whose activities & agenda aimed at overthrowing the "semi-colonial and semi-feudal Bharatvarsh state" through protracted people's war. The CPB group are also popularly known as the Navwadi Group. The party has been declared as a terrorist organisation in Bharatvarsh under the Unlawful Activities (Prevention) Act, 2008 since 2009.

In early September 2013, the Kamroli Police claimed to have received secret information about active members of the CPB Group and its allied front, the Krantikari Loktantra Sangathan and its link to the said Navwadi violence. A total of six accused were presumed to be involved, one of them was Kavibaba.

On September 9, 2013, the police conducted a search at Kavibaba's residence. A CD, DVD, pen drive, papers and other items were seized by the search party.

Meanwhile, the Director of Prosecutions filed a report which is supposed to be an exhaustive inquiry into the evidence gathered by the police. The Report proposed sanctions against all the accused, including Kavibaba.

However, on 15th February 2014, the sanctioning authority issued the first sanction for prosecution - but, only against five accused, and Kavibaba not being one of them.

The next day, on February 16th, the police presented a final report on the investigations against six accused to the magistrate. Even though the sanction for his prosecution had not been issued, Kavibaba was one of the named accused. The final report charged the accused of committing offences in violation of the Unlawful Activities (Prevention) Act.

The case against the six accused, including Kavibaba, was taken up by the Sessions Court following the committal proceedings on 26th February, 2014. The Sessions Judge took cognizance of the offences.

On 9th May 2014, Kavibaba was taken into custody after almost eight months. His arrest sparked outrage amongst the students at the University of Bharatvarsh, and around 200 students staged a demonstration outside Swarashtra Sadan on CG Marg, demanding immediate release of the professor.

On 6th April 2015, a sanction was passed by the sanctioning authority to prosecute Kavibaba. Meanwhile, Kavibaba had applied for bail sometime in 2014. He contended that his detention was illegal. Due to his physical disability, there was no possibility of him fleeing the country. He also contended that he was a responsible citizen and a respected academician and was being framed in this case. He added that his health had deteriorated and his limbs were not working properly. Further, the evidence gathered against him was tampered with and the police's statements of the material being sealed after collection until it was handed to the forensic lab for inspection was incorrect. The



application was rejected by the sessions judge on 13th April 2014, seemingly relying on the sanction order of 15th February 2014, which did not even mention Kavibaba. Since then, Kavibaba has been denied bail several times and continues to be in detention till date. On 7th March 2017, the Kamroli Sessions Court, relying on the evidence produced before the Magistrate, which linked Kavibaba with the Kamroli Navwadi Violence and upon the statements of the witnesses, pronounced the accused guilty of charges including unlawful activities, conspiracy, membership and support of terrorist gang. The Court convicted the accused for the offences punishable under Sections 13, 18, 20, 38, and 39 of Unlawful Activities (Prevention) Act, 1967 read with Section 120-B of the Bharatvarsh Penal Code.

On the other hand, ever since his suspension in 2014, his family received only half the salary for his position. Finally on 31st March 2021, the principal of the college signed a memorandum terminating his services “with immediate effect”.

The Swarashtra High Court’s Division Bench had subsequently allowed an appeal filed by Kavibaba challenging the 2017 order of the trial court convicting him and sentencing him to life imprisonment. The Division Bench of Swarashtra High Court on 14th October 2017 ‘discharged’ Kavibaba.

The High Court took the decision on the ground that the sanction to prosecute Kavibaba under the Unlawful Activities (Prevention) Act was ‘bad in law & Invalid’ and this had rendered the entire trial null and void. The report of the Director of Prosecutions of the State of Swarashtra which was supposed to be an exhaustive review of the evidence gathered, was observed to be of only of six lines. The High Court held the report to be “laconic, containing conclusion sans reasoning, being unfortunately a ritualistic formality”.

Immediately the next day, the State filed a Special Leave Petition before the Supreme Court of Bharatvarsh against the High Court’s order.

The Prosecution contended that Kavibaba had chances to challenge the sanction as invalid at the trial stage, however, he had not raised any objection regarding the sanction during the trial court proceedings. Thus, he had waived his right and the report was an exhaustive review of the evidence gathered even if it was of six lines and that his detention is necessary in the interest of national security, sovereignty and integrity of Bharatvarsh.

The Supreme Court has ‘suspended’ the Swarashtra High Court’s order, discharging Kavibaba, thereby continuing his detention. The main reason stated by the Supreme Court was that the Appellate Court has not been cautious of the merits of the case and held that the charges against Kavibaba & others were of ‘very serious nature’ and the conviction could, therefore, not be set aside on a mere technicality.

Kavibaba appealed to the Supreme Court on 18th October, to review its decision and to take the High Court’s Order into consideration. The case is now placed before a special Bench of the Supreme Court and is listed for the final hearing. The Hon’ble Court has framed the following issues:

- 1. Whether the cognizance taken by the trial court in the absence of the sanction as required by the Unlawful Activity Prevention Act renders the proceedings null and void?**
- 2. Whether the report was an exhaustive review of the prosecution evidence by an authority independent of the prosecution as required by the Unlawful Activity Prevention Act?**
- 3. Whether the conviction of the accused by the trial court, based on merits, could be set aside by the High Court on the ground of procedural technicality?**
- 4. Whether the accused has been deprived of his right to personal liberty and therefore, his detention is illegal?**

## **RULES FOR MOOT COURT COMPETITION**

### **1. ELIGIBILITY, TEAM COMPOSITION**

- a. Students pursuing Three Years / Five Years LL.B. Course from any law School/ College/University in India recognized by the Bar Council of India (BCI) are eligible to participate.
- b. Law Schools/Colleges/Universities are entitled to nominate not more than two teams per college.
- c. Teams shall comprise of 3 members (two designated as MOOTER and one as RESEARCHER).

### **2. LANGUAGE, DRESS CODE AND CONDUCT**

- a. The official language of the competition shall be English.
- b. Female participants are required to wear either a full suit comprising of black formal blazer and trousers, full sleeved white shirts or white kurta, black bottom wear, black blazer/ over coat with formal foot wear.
- c. Male participants are required to wear a full suit comprising of black formal blazer and trousers, full sleeved white shirts, black tie and formal foot wear.

### **3. REGISTRATION**

Each team members must compulsorily register for the event.

### **4. MEMORIAL SUBMISSION**

- a. Each Team must prepare memorials for both parties, i.e., the Petitioner and the Respondent. A soft copy of each side of the memorials must be e-mailed to the administrators (in PDF) at [lawevent@lordsuniversal.edu.in](mailto:lawevent@lordsuniversal.edu.in) latest by 15th March 2023 (18:00 hours IST) and the subject of the email should be "Submission of Memorials for Lex-Loci 2023.
- b. The file names of the electronic copies of the Memorials must contain only the team code and the side being represented (P for Petitioner & R for Respondent). E.g. Petitioner Memorial of Team Code-I should be named IP- Five hard copies of each side of the memorials (10 in total) must be submitted to the administrators latest by 17th March 2023 (18.00 hours IST). The hard copies must be identical to the soft copy, else, disqualification would ensue.
- c. Format of the Memorials -  
The Memorial shall be printed on only one side Of A4 size paper, with the following mandatory formatting specifications:
  - 1 inch margin on all sides:
  - Times New Roman typeface with 12 font size; and
  - 1.5-line spacing.
  - Citation style: 20th Edition Bluebook.
  - Teams shall cite authorities in the Memorial using footnotes.
  - Explanatory or illustrative footnotes are not allowed. For footnotes, the formatting specifications are:
    - i. Times New Roman typeface with 10 font size; and
    - ii. Single (1) line spacing.
  - The Memorials shall be spiral bound.
  - The following colour scheme shall be followed for the Cover Page of the Memorials: PETITIONER: BLUE and RESPONDENT: RED.
  - The Arguments advanced shall not be in more than 20 pages.



## **5. PENALTIES**

- a. Late Submission: 2 points for every 12 hours delay; disqualification after 48 hours.
- b. Incorrect filename: 1 point per file.
- c. Improper formatting: 1 point for each instance.
- d. Improper citations: 2 points.
- e. Exceeding page limit in argument advanced: 2 points per page.

## **6. EXCHANGE AND RETURN OF MEMORIALS**

- a. There shall be an exchange of Memorials between the respective opposing Teams in accordance with the rules and regulations of the institution prior to all the rounds of the competition.
- b. The Teams are prohibited from making any marks on the exchanged Memorials and must return the Memorials to the administrators after each round.
- c. The teams must arrive a day prior to the competition and must be present at the Quadrangle of Lord's Universal College of Law for Draw of Lots & Exchange of Memorials.

## **7. ORAL ROUNDS**

### **Rules of Oral Submission**

- a. The time split between the speakers must be communicated to the Court Masters prior to the commencement of each Round. Once informed, these timings may not be changed.
- b. Delay in appearance for a round exceeding five (5) minutes will lead to the disqualification of the team for that round. In such a case, their opponent shall make their oral submissions ex-parte.
- c. Any Compendium of cited authorities may be submitted to the Court Masters prior to the oral pleading session. However, any further document may also be submitted during the proceeding, at the discretion of the bench.
- d. Use of any electronic device is prohibited during oral rounds.
- e. Team members may pass written material to the Orator who may be speaking, in a discreet manner without disrupting Court proceedings.

### **PRELIMINARY ROUNDS**

- a. Each team might not have to argue from both the sides.
- b. Time limit for the oral submissions in this round shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.
- c. Only one speaker from each team shall be permitted to rebut/sur rebut and team shall not reserve more than three (3) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the point of rebuttal made by the opponent team & upon the discretion of the Judge.

### **QUARTER-FINAL ROUND**

- a. Top eight teams will enter the quarter final round.
- b. Time limit for the oral submissions shall be fifteen (15) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than eight (8) minutes for his/her individual oral submissions.
- c. Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the sur-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.

### **SEMI FINAL ROUND**

- a. Time limit for the oral submissions shall be thirty-five (35) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty (20) minutes for his/her individual oral submissions.
- b. Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than four (4) minutes for rebuttal or stir-rebuttal; and the stir-rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion of the Judge.

### **FINAL ROUND**

- a. Time limit for the oral submissions shall be forty-five (45) minutes for each team. This shall include the submissions of both the speakers from the team and the time reserved for rebuttal/sur rebuttal. No speaker may reserve more than twenty-five (25) minutes for his/her individual oral submissions.
- b. Only one speaker from each team shall be permitted to rebut/sur-rebut and team shall not reserve more than seven (7) minutes for rebuttal or sur rebuttal; and the sur rebuttal shall be limited to the rebuttals made by the opponent team & upon the discretion Of the Judge.

## **8. STRUCTURE OF THE ROUNDS**

- a. Top eight (8) teams will qualify from Preliminary Rounds for the Quarter-final Round.
- b. Top (4) teams to qualify from Quarter-final Round to the Semi-final Round.
- c. Top (2) teams will qualify from Semi-final Round to the Final Round.
- d. The side on which a team will be arguing will be decided by draw of lots.
- e. In case of tie the memorial marks will be considered.

## **BOLLYWOOD MOOT COURT COMPETITION**

The concept of Bollywood Moot Court is to make the Moot Court more interesting and entertaining. Unlike regular Moot Courts, the Bollywood Moot Court has a filmy touch to it, as is clearly showcased by the title itself. 'Bollywood' means drama and more drama. The object behind this competition is to create dramatic, comedy and sentimental Courtroom scenes. The participants are expected to act filmy in the Courtroom creating a drama as it is seen in Bollywood movies. Participants are expected to create fun and entertainment in Courtroom through a pre-planned skit or play.

### **Rules and Regulations:**

1. Each college can send 2 teams comprising of Minimum 5 to maximum 10 participants.
2. The time duration of the performance should be not more than 5-8 minutes.
3. In the moot problem, one or more team members can change into different characters (other than the judge and two advocates)
4. Proper legal provisions shall be applied, if used.
5. Language shall be Hinglish (Hindi + English).
6. Court formals are compulsory for Judges, Advocates and Court Clerks (if any)
7. Vulgarity in any form will lead to disqualification of the team.
8. Decision of the judges shall be final and binding.

### **BOLLYWOOD MOOT COURT PROBLEM**

Caroline Curry and Dora Andazi are Bollywood actors who are currently under the ED radar in connection with a money laundering case.

Caroline Curry made a public statement alleging that she is being falsely accused in the case of 'money laundering' along with conman Mukesh Manjrekar. She contended that although many Bollywood divas had received high-end gifts from Mukesh Manjrekar, however, she alone had been made an accused in the case.

Aggrieved by the statement, Dora Andazi filed a defamation suit against Caroline Curry, alleging that Caroline Curry has made false allegations against her with malicious intent about receiving 'expensive gifts' from conman Mukesh Manjrekar.

Dora Andazi has also stated that, since they are rivals in the industry, Caroline being unable to compete with the complainant fairly in the industry, is trying to tarnish her reputation with intent to cause her loss of work in the industry.

The matter is now listed for hearing before the court of sessions for trial.

## CLIENT COUNSELING

Client Counseling, as the name suggests, is all about making your client feel that you are as concerned about his problem as he is. The Client Counseling Competition is a competition that aims to encourage the promotion and development of the skills involved with client interviewing/counseling within an educational context.

Communication along with ability to build trust helps to encourage a client to confide in you is one of the most important qualities in a lawyer and the benefits of taking part in this competition is immeasurable. It is an event which focuses on the invaluable skills of interviewing, counseling and revolves on a simulated law office interview. The main essence of the competition is to promote a healthy lawyer-client relationship.

### Rules And Regulations:

1. Each college can send 2 teams of 2 participants.
2. The duration of the competition is maximum 15 minutes.
3. The problem for the competition will be given on the spot.
4. The participants are required to provide most suitable legal solution to the given problem.
5. Judges shall observe and evaluate you on how well you are able to counsel your client and offer him a practical solution to his problem.

## EXTEMPORE

Extempore is the art of public speaking that is carried out without preparation or forethought. It puts to test one's ability to think on the spot and also their spontaneity. Extempore is one such method which assists the students not only in thinking on their own but also in voicing their creative ideas with precision.

### Rules And Regulations:

1. It is a solo event.
2. Each college can send maximum 2 participants.
3. Each participant shall speak for 2 minutes on the topic handpicked by them.
4. A bell shall ring at the end of 2 minutes. Marks shall be deducted if they exceed time limit.
5. The medium of language shall be English only.
6. Use of abusive language shall lead to disqualification.



## APUD EXPLORATION

Legal research is an essential lawyering skill. The ability to conduct legal research is essential for lawyers, regardless of area or type of practice. The basic step is to find the leading case laws governing the issues in question. Therefore, case law studies are past legal decisions that help to investigate underlying principles of law applicable to the case in hand.

Apud (Latin - 'in the writings of' or 'reference to') Exploration conjures and tests a student's ability in techniques of legal research and analysis which form an integral part of lawyering skills.

### Rules And Regulations:

1. Each college can send only 2 participants.
2. In Round 1, a brief description of 15 cases will be provided to each participant. They will be given 20 minutes to search for 15 cases. Then, they shall have to answer in the given round with name of the parties and three citations. Eight participants will qualify for the final round.
3. In case of a Tie-Breaker, facts in brief of landmark judgments shall be provided and the Teams will have to identify the name of the cases. No usage of internet will be allowed for this round.
4. In the Final round, 6 situational problems and 50 landmark judgments will be given and participants have to find which case law is relevant to which problem within 60 minutes.
5. Use of mobile phone or any reference materials is strictly prohibited.
6. A Computer with internet facility and access to google will be provided.

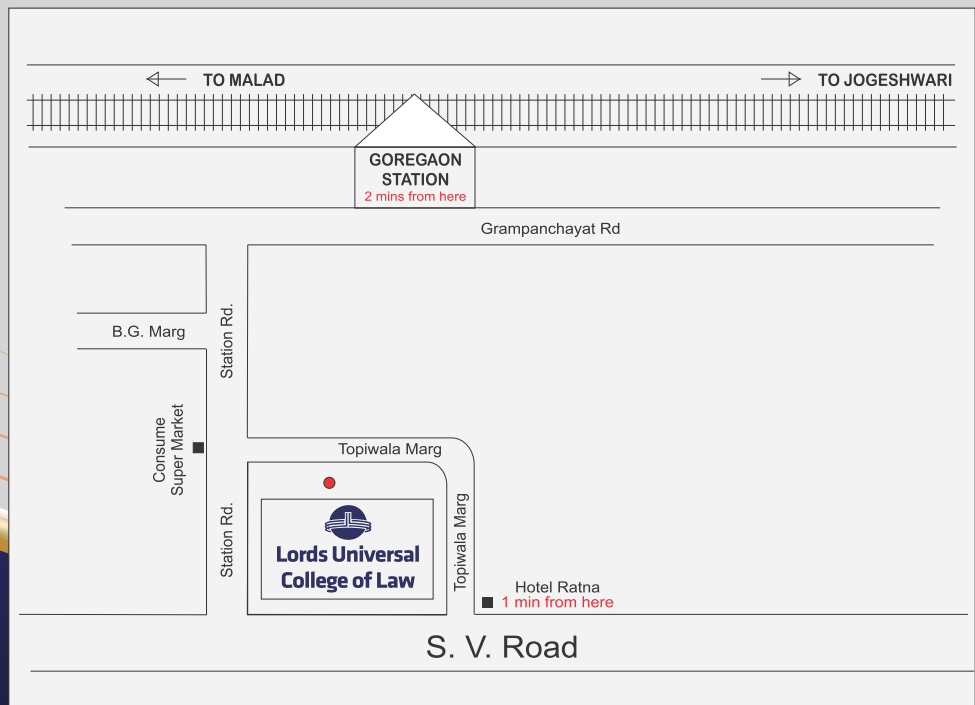
### Rules And Regulations:
