- **Footnotes:** Footnoting style: Bluebook 20th Edition, Times New Roman, font size 10, single spaced
- **Margins:** 1 Inch on all sides
- **Word limit:** Abstract should be 300-500 words with keywords and must be accompanied by the name, designation, and contact details of the Author(s) and the word limit of a full Paper is 3000-5000 words exclusive of Footnotes.
- **Full paper shall be submitted with a plagiarism report of less than 10%.**
- **Co-authorship:** up to two authors.
- **All the submissions should be sent to [genderstudies@ifheindia.org](mailto:genderstudies@ifheindia.org)**
- **Selected papers will be published in a book with an ISBN.**
