Public interest litigation (PIL) is one of the most indispensable parts of our legal system. This competition aims at giving the budding minds of the legal fraternity an opportunity to understand the practical dynamics of PIL.

We bring forth SOCIETAS ACTUS LITIGARE- Public Interest Litigation. in hopes of promoting the object that was set forth by the Center for gender studies under the guidance of our director Prof. A V Narsimha Rao.

SOCIETAS ACTUS LITIGARE- PRO BONO COMPETITION

ROUND 1

Round 1 will constitute the selection of petitions submitted by the participating teams. It will be called the Petition selection round. The round will imitate the memorial selection round in a moot court competition wherein multiple factors like the topic of the PIL, the accuracy of the research and other factors will be the basis on which the petition will be selected.

ROUND 2

Round 2 will be the oral presentation round wherein the participants will present their petitions in a team of two and co- counsels. Marks will be appointed to the presenters by the judges on their speaking skills, the answering of the questions by judges, courtroom mannerisms and other factors.

ROUND 3

Round 3 will be the analytical round wherein the co-counsels shall attempt a test, together. The test shall imitate the analytical section of CLAT wherein the question will not be on the facts of the case but on the common knowledge of the topic on which the Petition has been drafted. The test shall focus on knowledge gained through research and not on memory of facts and case laws used in the Petition.

TOPIC- HORIZONTAL RESERVATION OF TRANSGENDER PERSONS

1. Each Participating Team must submit one PIL draft.
2. If a participant/team wishes to submit any annexure to support their arguments contained in the PIL (for instance Reports, Commentaries, News Clippings, Pictures, etc.)
3. A compendium of all the relevant annexures must be prepared and should be sent along with the memorial.
4. All PIL drafts must be sent to the email address: genderstudies@ifheindia.org with the Subject of the email as "PIL Draft, Team Code _"
5. Any submission made after the deadline will not be considered for evaluation and will result in the cancellation of candidature as well as forfeiture of the contribution made.
6. Any submission with any name reference of the participant will be disqualified.
7. Substantial Plagiarism or AI-generated work shall amount to disqualification, therefore, the participants must not submit plagiarized or AI-generated content
8. It should be noted that at any point in time and in case of any conflict the decision of the committee shall be final and binding
