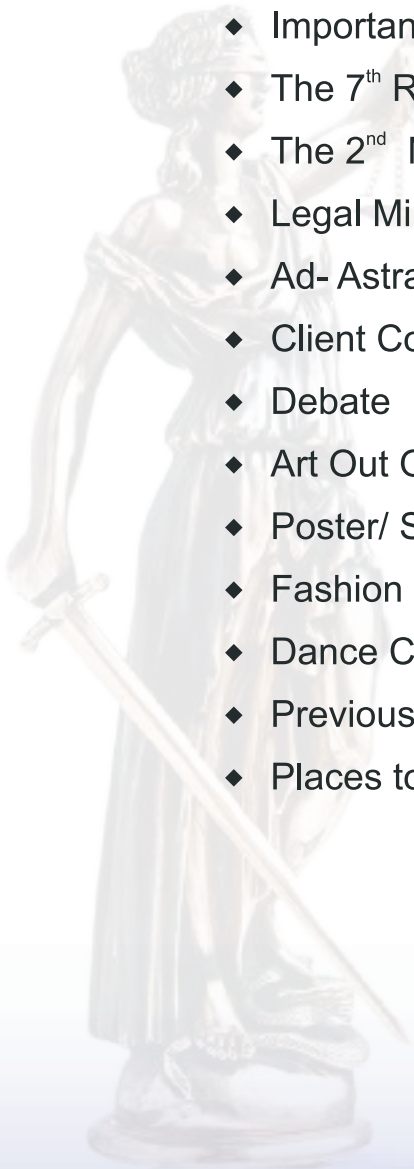


—ABOUT THE JURIS FIESTA—

First Round

7. *This round will consist of 50 questions which shall be in form of multiple choices of questions for which half an hour will be given.*
8. *1 mark to be awarded for each correct answer and 0.25 marks shall be deducted for ever wrong answer.*
9. *Only one participant from each team can attempt the quiz. In case, if both the participants attempt the quiz, the response which is submitted earlier shall be considered.*
10. *Top 10 teams will be qualified for next round.*
