The National Law University and Judicial Academy, Assam (NLUJAA) has been established by the Government of Assam by way of enactment of the National Law School and Judicial Academy, Assam Act, 2009 (Assam Act No. XXV of 2009). The word 'School' was replaced by the word 'University' by amending the National Law School and Judicial Academy, Assam (Amendment) Act, 2012. The Hon'ble Chief Justice of Gauhati High Court is the Chancellor of the University. NLUJAA promotes and makes available modern legal education and research facilities to students and scholars drawn from across the country, including the North East, coming from different socio-economic, ethnic, religious and cultural backgrounds.

- Registration Fee: Rs 500 per person (including adjudicators and speakers)
- Early Bird Discounts: Rs 400 per person (valid until 15th May)

- How to Register:
  - Step 1: Participants need to fill in their details in the Google form before 25th May, 2024 through the given link.
  - Step 2: Payment of Registration Fees:
    - Participants: Rs 500 per person
    - Adjudicators: Rs 500 per person



- Step 3: After successful payment, participants are required to add the receipt of the payment to the registration form.

# ELIGIBILITY

- The Competition is open to all students, enrolled bona-fide on a regular basis in an undergraduate or postgraduate course conducted by any recognized Institution/College/University.
- A recognized Institution/College/University shall be entitled to send a maximum of 2 teams to the Competition.
- Each team shall comprise 3 members + 2 Adjudicators

# MODE

The debate competition will be conducted online.

# GENERAL RULES OF THE DEBATE

- **Platform:** Zoom
- **Team Size:** 3 members per team; N+1 Adjudicator policy.
- **Motions:** Revealed upon entry to Zoom meeting room; teams rank preferences, and mutually agreed motion is selected.
- **Preparation Time:** 20 minutes after motion announcement.
- **Video Requirement:** Cameras must be on during preparation.
- **No Communication:** No communication within teams after motion release.
- **Punctuality:** Timely arrival is crucial; latecomers forfeit the round.
- **Language:** Respectful discourse is expected; use of foul language.

**Format:** Two preliminary rounds with teams followed by quarter finals, semi -finals and finals.

# PRIZE POOL

The rewards for the participants stand as follows-

- Best Team Award- Rs. 20,000/-
- Runners - Up Team Award- Rs. 15,000/-
- Best Speaker- Rs. 7,500/-
- 2<sup>nd</sup> Best Speaker- Rs. 5,000/-
- Best Adjudicator- Rs. 7,500/-
- 2<sup>nd</sup> Best Adjudicator- Rs. 5,000/-


Additionally, the participants will be awarded with a Certificate of Participation.
